PENDING EXECUTIVE BUSINESS

Calendar No. 21. The nomination of George Harrold Carswell, of Florida, to be an Associate Justice of the Supreme Court of the United States. The pending question is the motion of the Senator from Indiana (Mr. Bayh) to recommit the nomination.

UNANIMOUS CONSENT AGREEMENT

Ordered. That effective on Monday, Apr 6, 1970 (with the Senate convening in executive session at 10 a m.), further debate on the nomination of G. Harrold Carswell to be Associate Justice of the U.S. Supreme Court, with the pending question on the motion of the Senator from Indiana (Mr. Bayh), to recommit the nomination to the Committee on the Judiciary, be limited to 3 hours to be equally divided and controlled by the Senator from Indiana (Mr. Bayh) and the Senator from Nebraska (Mr. Hruska), or whomever they may designate, with the vote coming at 1 o'clock, or following a vote on a motion to table the motion to recommit if such a motion should first be offered. Following the above vote or votes the Senate will proceed to vote on the confirmation of the nomination at 1 o'clock on Apr. 8, 1970, or following the vote on a motion to table the nomination should such motion be made, and if the nomination is still before the Senate.
